#### **Appointment of Vestry Clerk**

#### **Approval of Vestry Agenda**

Glenn Clark has suggested that 'New Business' be handled before the presentation of the Financial Statement and Budget in the event that New Business involves any spending.

Glenn Clark also suggests that the Agenda be revised to have the 2021 Budget appear after all the Financial statements are presented. In other words, items 19 following Item 23.

These changes should carry forward to future years.

The Agenda for the Vestry Meeting dated February 24, 2021, is approved as amended. Moved by Glenn Clark, seconded by Deb Donoghue. CARRIED.

#### **Approval of 2020 Vestry Minutes**

The Minutes for the Vestry Meeting dated February 19, 2020, are approved. Moved by Brenda Houle, seconded by TAD Higginson. CARRIED.

Glenn Clark suggests that the Vestry Minutes be reviewed immediately prior to publishing the following year's Vestry Report to make sure that action items concerning the Vestry Report itself are completed.

#### **Nominations Open**

Reverend Joan Riding opens nominations for People's Warden, Deputy Warden, Members of Parish Council at Large, Synod Delegates, Alternate Synod Delegate, Auditor, Chair of Cemetery Committee.

2020 Reports

The Vestry Meeting accepts the Reports numbered 5 through 13 in the Vestry Agenda as published in the Vestry Report. Moved by Mike Thomas, seconded by TAD Higginson. CARRIED.

The electronic version of the current Vestry Report be corrected by TAD Higginson with regards to typographical and grammatical errors at the direction

## of Reverend Joan Riding and a PDF copy be provided to Glenn Clark for posting on the website. Moved by Linda Cutts, seconded by Deb Donoghue. CARRIED.

#### **Wood's Cemetery**

Glenn Clark spoke with Vic Wootton Jr. on February 24, 2021, regarding cemetery maintenance. He is agreed to do the job again in 2021 for the same price and has agreed to better adhere to the maintenance biweekly schedule and to remove most of the tree stumps left by a tree removal contractor in September 2020.

#### **On-going Business**

#### St. James and the COVID Pandemic

Reverend Joan indicated that her report includes a lot of information on this subject. The Deanery indicates that the pandemic will not be going away soon, and we cannot be opening in the near future and when opening does happen, each parish will open with its own timing. TAD Higginson asked about ventilation issues. Deb Donoghue indicated that there were problems with air movement, humidifiers, air conditioners and fans. Their use needs to be limited to restrict the circulation of the virus.

#### **Outreach during the Pandemic**

We will continue to support the Food Bank, Operation Christmas Child, the Rotary Home and the Christmas Lights.

Glenn Clark brought up the issue of the Christmas Lights. Glenn has suggested that the problem lights (nativity and Merry Christmas sign) be retired, and we search for a new nativity scene if possible. Also, the individual outdoor plugs may require repair and that the plugs be placed on separate circuits on the electrical panel to spread the load from the light display. Linda Cutts indicated that they will cover their neighbour electrician to make the necessary repairs and adjustments.

Linda Cutts thanked Reverend Joan Riding for all the outreach by phone and letters to the individual parishioners. There was round of applause.

#### Re-opening St. James

Reverend Joan spoke about the possibilities and risks of re-opening. There was a discussion, and it is likely that we won't be able to open any time soon.

Glenn Clark suggested that the church re-open with a celebration when it is deemed safe. Reverend Joan indicated that the Diocese would like parishes to continue with online services after the church re-opens. Glenn Clark reminded that this might create more work for Reverend Joan and the wardens, and we need to be conscious of this before making any plans.

#### **New Business**

There was a discussion of succession and getting new volunteers.

#### **Next Parish Council Meeting**

Monday, March 15, 2021, 7 p.m.

#### **Votes of Thanks**

TAD Higginson offered thanks to the wardens. There was a round of applause. Glenn Clark offered a vote of thanks to our Treasurer, Mike Thomas. There was a round of applause.

Mike Thomas offered thanks to TAD Higginson and Sandra Donatucci and Grace Jones for hosting the on-line services and for printing the Vestry Report. There was a round of applause.

#### **2020 Financial Statements**

The Vestry Meeting receives the 2020 Financial Statements as published, including those for Wood's Cemetery and the Ladies' Guild. Moved by Mike Thomas, seconded by Sandra Donatucci. CARRIED.

#### **General Fund**

Total cash is \$34,257.85 and split into various funds.

#### **Envelope Secretary Report**

This provides a breakdown of how donations are made. Three people contribute \$14,974.21. Total donations by regular donors were \$45,159.21 with overall donations of \$45,894.21

#### **Wood's Cemetery**

Surplus was \$1,327.59. Trust Dividend was 4,015.06 and donations totaled \$1,531.20. Bank Balance is \$4,561,09 and GIC with value of \$6,836.65.

#### Ladies' Guild

Little activity because of COVID cancelled most events. There was a deficit of \$123.71. Expenditures included catering for the Celebration service for Alice Purdy in January.

#### 2021 Budget

Mike Thomas presented the budget and there was a discussion. The following revisions were made.

Mike Thomas reported that our March 2021 diocesan payment of \$2,969 were being cancelled, which will be covered by a government program. This reduced our Priest expenses from \$25,350 to \$22,687.50 including the elimination of the budget for extra days of \$600 that applied to the previous minister. Other diocesan expenses were also reduced from \$10,879 to \$9,972.41. Mike Thomas eliminated revenue of \$3,500 for the Yard Sale, and Yard Sale expenses of \$422.46 not likely to take place in 2021. The

Foster's Market was changed from \$1,500 to 1660.98 reflecting the payment received early in 2021.

Total revised Revenue for 2021 of \$46,560.98. Total Operating Expenses of \$13,248.54. Total Expenses \$45,908.45. Surplus \$652.53

Mike Thomas also mentioned that there was \$8,000 in the Consolidated Trust Fund in addition to our bank account cash.

The Vestry Meeting approves the budget for 2021 as revised. Moved by Mike Thomas, seconded by Linda Cutts. CARRIED.

Mike Thomas was thanked again.

#### **Nomination Report**

Reverend Joan Riding closes the nominations.

The Vestry Meeting approves the Nominating Committee Report. Moved by TAD Higginson, seconded by Sylvia Thomas. CARRIED.

#### **Appointments for 2021**

Glenn Clark, Karin Ferrol, and Linda Cutts to be added to the list of Intercessor and the latter two to the list of readers. Karin Ferrol, Linda Cutts and Glenn Clark are to be included in Psalm Readers. Irene Thomas to be added to Servers. Sandra Donatucci is to be added to the Ladies' Guild.

The Vestry Meeting accepts the Appointments and other reports numbered 25 through 27 in the Vestry Agenda as published in the Vestry Report and as amended. Moved by Sandra Donatucci, seconded by Irene Thomas. CARRIED.

#### **Adjournment**

The meeting adjourned with the Lord's Prayer and the Grace.

# Report of the Priest-in-Charge, Parish of St. James, Leitrim. aka Joan's Report to Vestry

The Church's one foundation Is Jesus Christ her Lord:

Each year as we gather for Vestry, we begin by thanking God for our life together, for the love we experience, and for the hope we share in each other's life and ministry.

To begin, we give thanks to God for the lives and ministries of Clara Stuart
Garry Cutts

Each one has enriched our lives and we miss them deeply. *May they rest in God's peace and may Light perpetual shine upon them.* 

Whether you have been part of the parish for a few years, or for many (in some cases, many, many) years thank you for being part of this parish. I hope you will always find this, as I do, to be a wonderful community of challenge, peace, spiritual refreshment and caring.

In my report to Vestry, it is my responsibility to present a picture of what I understand about the life of our parish and to describe my part in it.

Please travel with me through my diary as I review the year 2021 from my point of view. I think it would be fair to say that our year together has been marked once more with the presence of the pandemic, covid. Marked, but not marred! To say that it has been a difficult year would be a gross understatement, but this also has been a year of deepening faith, sharing of hope, and serving our community.

In January, since Ottawa had remained in lock-down (a new word in our vocabularies), we continued to meet on-line, even for worship. We agreed that I would continue my programme of contacting everybody on our parish list every six weeks just to chat, and weekly (at least) for those who were ill, isolated, or needing a bit of extra care. I continued to produce a short service of Evening Prayers which Glenn Clark sent to everybody so that we would have another opportunity to worship together even though not face to face. Thank you to Deb Donoghue for the pivotal role she continues to play in our pastoral care programme. Deb sends cards and phones people. She visits and she even has organized meals. Thank you so much for your generosity in this ministry. You make a real difference.

We continued to worship together with All Saints, Greely, using the Webex system offered and run by the generosity of TAD Higginson, with Grace Jones as his assistant, with Victor Wootton and Glenn Clark producing and sending our the weekly service material. Because of the technicalities of "virtual" worship, we could not sing together, but Irene Thomas played the family organ from home and MikeThomas led the

singing from home. Since it was from the same home, the technicalities worked and we had music. Thank you to Irene. She chooses, prepares and plays our music. Irene does not charge as almost all church musicians do; rather, she freely offers God and us her gifts of skill and joy in her ministry.

We sent out little notes, thoughts and jokes as well as parish information to help strengthen our sense of community and keep us close. We aim to be hopeful while not offering false ideas of a quick end to this plague. (You may notice that I do not accord covid the dignity of a capital letter "c". This is my small act of defiance.) Thank you to everybody who laboured together to make all this ministry possible and smooth.

#### WE ARE DISCIPLES OF JESUS

As always, February was a month of loads of administration work with new challenges as we prepared for our first Parish Vestry meeting on-line. We heard the distressing news that several parishioners were very ill. In other circumstances, I would have visited at the hospitals, but sadly, that was not possible due to the lockdown. In addition, unfortunately a wedding had to be postponed.

Lent began in February. I tried to find a suitable study or book group but was not able to find one to work for us. I am back to doing that search again for 2022. Also during February, we launched something new. Laurie Brown and Aileen Lamont from All Saints, and Victor Wootton from St. James all offered to preach, one person every four to six weeks. That would provide you with a range of wonderful preaching with different points of view from my own. And it offered me a welcome rest from Reflection preparation, as well as regular opportunities to concentrate on other projects, for example, Vestry reports. I am so grateful for this pastoral care for me, and enriching preaching styles for you

#### THE LIFE OF JESUS INSPIRES US.

March came in like a lion, and we joked about being careful travelling to church! We dared to hope covid would soon be over because a vaccine programme had begun. We compared appointment dates for our "shots" and conversations sounded more relaxed than they had been for months.

We discussed the possibility of gathering outdoors for Easter, but the weather was still too unpredictable and cold. We marked Holy Week, sadly realizing that, again, we would not be together in person, and yet grateful that we had the technology to see and talk with each other as we prayed together. Happily, we were able to drop off a few flowers as Easter surprises for some of our senior parishioners.

#### THE MESSAGE OF JESUS ENDURES.

April, Easter. This was an amazing start to the month with 39 people online together for Good Friday and 43 for Easter. We had wonderful organ music from Irene, and Scott Kirby provided trumpet music from his home

As the month progressed, word spread in the community that we were praying for people suffering with covid, as well as for their families and friends. As a result, more and more people requested our prayers. Such trust from our community and such privilege for us.

We participated in the launch of the Shape of Parish Ministries and Buildings Consultation, SoPM&B, and you will see a report about this work further on in the Vestry Report. After that meeting, we sent the prescribed questions about our parish to all our parishioners and asked for response. We gathered twice to discuss the responses and then sent them to the consultants. That programme continues in 2022. So, during April, May, June and into July, a lot of work had to be devoted to that project so that our responses would be accurate and complete. The work for the SoPMB switched into high gear as we laboured over parish responses to the assigned questions from the diocesan SoPMB coordinating team. Three Zoom meetings and lots of revisions! But we were able to submit our report on time. God gave us the grace to do it, and to help us keep looking forward realistically.

#### THE LOVE OF JESUS CALLS US.

May was a wonderful month in many ways. The weather was good and our gardens responded well, so people driving by had a beautiful sight. May and June are the months we usually host our Yard Sale with Entertainment and Strawberries, our Cemetery Service, and Blessing of the Animals service, so we had to shift our way of doing those services again this year. We invited people to log in at the same time as usual, with the same service, but from their homes. All those decisions to forego having people together were painful, but the Wardens and I agreed that they were in accord with our provincial rules, diocesan rules, and that "virtually" was the only safe way to be together.

#### THE HOPE OF JESUS ENDURES.

During June, the provincial covid numbers began to improve, so we began to plan the re-opening of our own building. We were even given a large financial donation to cover the cost of the heavy work. We had to plan the cleaning, marking of seating because of numbers limits, airing the books, and records keeping. Turned out that we did not re-open until September, but we were prepared by then.

Scams. During the summer, e-mail and phone scams proliferated and that has continued. (I think people are desperate for money.) Several of our parishioners were targeted. So, if you receive strange or unusual financial requests or other requests for help from me, please be extremely careful. Contact the person

purporting to be represented in the communication. Contact the police. Scammers take advantage of our trusting natures!

During June, I cut back my phoning and e-mail contacting since we generally had more freedom to gather, therefore less isolation. I continued the weekly calls to people who remained isolated or in fragile health. By the end of June, we had welcomed our friends from Fosters Farm. They set up on our front lawn. People passing are pleased to have this convenience without having to go to a store, Fosters is happy with the revenue and we are happy because of the revenue as well. We promote almost everything that gets us noticed in a good way!

Our National Indigenous Day of Prayer and Canada Day services took a different and much more heavy-hearted tone this year with the terrible discovery of the bodies of Children buried on residential "school" grounds.

#### THE MISSION OF JESUS IS HEALING.

July and August were holiday months for many of us, and our covid numbers continued to abate. I split my holiday between July and August. Plans were made in case of any pastoral needs, and our Preaching and Worship leading group undertook the worship leadership for those weeks. Thank you for my holiday which I really needed.

As you may remember, I was engaged by Bishop Chapman to be the Priest-in-Charge of both All Saints and St. James, and the plan was for me to offer one worship service in each parish each Sunday. With the preparation time included, Sunday would count as one full day. Other parish work would be half a day in Greely and 1 day at Leitrim, for a total of 2.5 days per week. That plan mostly worked before covid, but as you can imagine, much more time was needed to deal with the extra pastoral work, as well as planning, and administration. Thus, I was a bit tired and ready for a holiday. Thank you for those five weeks, I really did enjoy the whole time and then I was very happy to be back.

While I was away, St James continued to give food to the Greenboro Food Bank. The church grounds were beautifully kept as an invitation for anybody to set a while in the garden.

#### THE GENEROSITY OF JESUS ABOUNDS.

We heard from our Bishop in August that our church buildings would have to open with restrictions by September 12. The final touches were added to the cleaning. Seating options and paths of movement were marked. Worship options were discussed and put into action. We invited our friends from All Saints to continue to participate with us in "virtual" worship, and we were pleased they accepted. That decision meant we each had a choice: worship in person in St. James Church building, or worship on-line with some folks from All Saints, in a service hosted by St. James. I

think having the choice was a good thing because it allowed us different ways of being together, which is always important.

The first Sundays back home in our beautiful church building were a bit grim. Those present had to work out how to keep a distance, wear a mask and hear each other, while singing and speaking quietly so that we would not spread germs! Grace Jones managed the phone links for the All Saints folks and we were able to share the St. James system. Grace also ran the whole system on occasion. think our kind of system is called a hybrid since it allows both live, in-person gathering, with live on-line participation.

You know I have a hard time learning to use new technology, but I was given a fabulous set of earpieces, and I became so comfortable with them that I even accidentally wore one home on the third Sunday. Although I chuckle at the memories now, it was a difficult and stressful time for all of us with many people not yet able to participate in-person because of illness or vulnerability, some not liking the technology of on-line and others not liking having the technology in the church building. But we all worked together, persevered, and trusted each other's best intentions! This was our set-up for the three months until mid-December. More on that later. Thank you to TAD for your real idea for "virtual"gatherings. Thank you for your generosity through this whole covid pandemic. TAD has repaired, enabled, given lessons, set up systems, and imagined improvements, all with courage, grace and the kindness and patience of a saint. I am firm in my belief that we would have been at a real loss without TAD. Thank you also to Sandra who provided back-up help, and to Grace Jones who made it work for the people at All Saints. And thank you to everyone who ran or tiptoed into this new process to give it a try.

#### **JESUS PRAYED**

October was fairly calm by comparison. Clergy had a half-day "virtual" meeting with our Primate to get to know her, to listen to her encouragement, and to pray with her. That was such a treat.

Clergy also participated in the first of three two-hour "virtual" workshops about racism and other exclusionary "isms", such as sexism and ageism. We discussed how to recognise and address these tendencies in in ourselves, in our churches and in society as a whole.

Our worship in-person began to feel as though we were a bit more organized and prayerful instead of being so concerned about distances and the mechanics of being safely together. Irene was back playing. We celebrated in the beauty of our building and the joy of togetherness. Thanksgiving was gorgeous, and we planned for November and Advent.

All of our activity was supported by the financial stewardship provided by, Mike Thomas, our faithful and diligent treasurer. Mike manages funds so generously

donated so that there is enough money to give away as we have planned, sufficient money to pay our bills, with some funds for building repairs, and for such future necessities as a ramp, for example. Thank you, Mike, for your care in the management of the finances at St. James, and for your kindness in the way you guide us through it.

At the end of October, our parish participated in our second on-line Diocesan Synod. We missed the contact and ease of communication with friends and other parishes, but it was very exciting to be able to have such a large meeting.

## GOOD ADMINISTRATION AND STEWARDSHIP STRENGTHEN OUR MINISTRIES.

By November, we were hearing about a new variant of covid that was highly transmissible, though in most cases less serious for vaccinated people than previous variants had been. Shadows began to gather again about worshipping together in-person.

We marked Remembrance Day, All Saints and All Souls Days, and the Feast of the Reign of Christ. It felt to me like we were running a race but having to watch over our shoulders as a giant was quickly catching up from behind us. I increased my number of weekly phone calls and e-mails in an effort to mitigate loneliness and worry. Clergy had another two hour "virtual" zoom meeting with our Bishop to share resources, for prayer and for just the opportunity to talk together about our experiences with our parishes. By the end of the month, it became clear that our celebrations of Christmas would not be as we had hoped.

I spent one delightful day being driven around our neighbourhoods to drop off little wooden tree ornaments to our parish children and grandchildren. I wanted them to know that the people at St. James were thinking of them, and to remind them that God loves them.

#### JESUS HEARS OUR PRAYERS

In December, the decoration of our church began, because we still hoped we might worship together in our church building. The outside lights were magnificent and we are very grateful for the large donation to support this outreach. The display is intended to be a gift for all who pass by. Bank Street gets so clogged at suppertime and we offer people a glimpse of beauty, joy, hope, and the love of God. Inside, the Advent lights were amplified with the mixed colours of Christmas and decorations were added. The creche was put into its place, all to welcome Jesus who came to us as a baby. St. James looked beautiful, thanks to the leadership of Glenn outside and William with most of the Thomas family inside.

As you know, our worship takes hours of work by several people to plan. In December we had to plan two versions of several parts of our worship services because we didn't know whether we would be in our buildings or on-line. At worship, there was increased tension on peoples faces. Most people were also making two sets of plans at home for Christmas celebrations, even with menu alternatives.

On Saturday evening, December 18, a message was sent by our Bishop to announce the necessity to cease in-person worship beginning immediately. (This late announcement was due to computer malfunctions.) For me, while this news was a disappointment, it was even more a relief. So many people were falling ill so quickly. Many quick phone calls were made to pass the news along.

The very next day, people worked together and we had a Lessons and Carols service with a <u>pageant</u> on-line. Wearing costumes. Who ever would have guessed that it could be done?!! But TAD had taught us well and it was really a wonderful celebration. And, instead of being miserable as I had feared, we were joyful and imbued with hope. This was a Christmas miracle for us. It carried right through to our Boxing Day worship, and continues through this date, January 29, 2022.

#### **JESUS BLESSES US WITH JOY AND PEACE**

Thank you for reading this report, and please don't stop just yet because this last part is really important. Thank all of you in the parish of St. James, Leitrim. Thank you for receiving my phone calls and for responding to my emails. Thank you for welcoming me into your lives as you do; you are so very kind and generous. Thank you for your part in our parish, for the gifts you offer so freely, and for the care you give one another.

In particular, and on behalf of all of us, I want to thank our two wardens for their unstinting service to God through our parish. When I was first brought to St. James to look around and meet the Wardens, the Archdeacon told me a bit about the parish, and then he switched and got kind of a far away expression. He said that both Glenn and Vic were "Salt of the Earth people". Over the past four years, I have found that to be true.

Glenn Clark has been our Peoples'Warden since 2002. Twenty years! Wherever there is any kind of gathering, Glenn is there, usually with delicious food. Glenn also would have been part of planning of the event. The gardens welcome us and invite us to notice God's beautiful gifts to us. Glenn produces our bulletins and organises our You-tube music selections. Glenn does many things and manages much of our parish life together. But more important than the visible work that Glenn accomplishes is his inner self. glenn is kind and generous. He sees needs and quietly takes action. ### People's Warden's Report for 2021 By Glenn Clark

Here I am writing another year in review.

What can I say? 2021 was really a mixed bag for both our parish and our community. It was the second year of the Covid pandemic with a serious flare up of the Omicron variant just before Christmas. With God's help and a big thank you to all our church members, we again were able to end the year with a surplus of \$3,613.28. Our bank balance, investments, and receivables now total \$46,499.82. Financially, St. James is in good shape, at least for now.

Covid has presented a major challenge in keeping our parish community and parishioners healthy. It has been difficult to live without in person interaction. We miss the social events that helped build our community beyond our weekly worship services. There has been a positive side as we have learned to handle technology better. With the help of TAD Higginson, Sandra Donatucci, and Grace Jones from All Saints Greely, we were able to have weekly worship on-line using Webex software through the entire year. This has also made it possible for those who live some distance from the church or cannot come because of health limitations to still participate in worship. Of course, on-line worship made normal sharing of the Eucharist impossible.

#### **Church Re-Opening**

As the year progressed, I waited with a degree of anxiety for the pandemic to ease so that we could re-open the church. It was always on the Parish Council Agenda, month after month. This finally happened on September 12<sup>th</sup>. As it turned out, I could not attend as I was able to travel to the west coast at the same time. But as soon as I returned, I was anxious to celebrate the Eucharist in-person with at least some of my church family. I thank TAD Higginson again for purchasing the necessary equipment and being involved with the installation of the Internet in the church for the first time. There were glitches as there always are when using new technology but one by one those glitches were resolved.

The church opened with restrictions as to numbers allowed, social distancing (2 metres between families), masking and good air circulation using the overhead fans and keeping the doors and windows open. With a chill in the air as we moved into fall and constant road noise, it became necessary to close the outside door. I also thank David Picklyk for being willing to handle worship reservations.

To compensate for keeping the door closed, a better filter was installed in the furnace and an air purifier was purchased. I think it was a relief for some parishioners that we were again worshipping in person. Not everybody enjoyed the on-line experience. But the 30% capacity restriction meant in-person attendance was under 20 every Sunday. We had a lot to be thankful on Thanksgiving Sunday when the church was beautifully decorated. It is too bad that more could not have seen how beautiful St James was.

There was a degree of optimism as we moved through the fall, but there was still an underlying nervousness about Covid. Despite requests, we were not ready to restart a service at Bridlewood Retirement Home, and some of our Christmas events were just not going to happen. Everybody was still nervous about Covid.

#### **Christmas Lighting**

There was no reason to not light up the church again as we have done for several years. This was a Covid-proof event.

Before, we could embark on our lighting setup in the fall, we first had to repair the outdoor plugs. One of the outdoor circuits had failed the previous winter affecting two sets of plugs on the north side of the church. Thanks to Linda Cutts, we were able to hire her neighbour, an electrician. He was able to replace the plug that was no longer working, and he split the outdoor circuits, so that they used two breakers in the electrical panel. This will help make sure that our outdoor lighting does not exceed the limits for each breaker. Our electrical panel is now at capacity.



Our lighting plans even included a short ceremony at the church doorstep, singing a few carols for our visitors. This happened on Thursday, December 2<sup>nd</sup>, and as tradition, it was another wet evening that immediately shorted out the light display on the north side of the church. As the technician for the light display, I had to scramble to try to keep most of the lights on while we had visitors on site.

The short-out problem has existed almost since the first year. For 2021, I retired our original nativity scene, and 'Merry Christmas' sign which were both not entirely waterproof. After finding four damaged extension cords, the light display stabilized but some problems remain whenever the weather is wet and above freezing. All the cords will be thoroughly checked next summer.

The new parts of the display included a nativity scene, a white and red light wrap for one of the tree trunks and a dancing snowman. I have always resisted buying inflatable ornaments but after talking to a gentleman who was so excited about finding the snowman, I had to give it a try. The gentleman said that the kids in his neighbourhood loved his previous inflatable ornaments and as a big kid himself, he had to have one. On lighting night, Greyson Dowhan was mesmerized by the snowman as he ran around and around it. It appeared to be very short-lived when it stopped working the very first week. I dismantled it, brought it home, thawed it out, and found that the problem was only a tiny blown fuse. It has worked ever since.

As was the case last year, I decided to keep the light display going well into winter, the church was flooded with blue for Advent, red and green for Christmas and now red and pink for Valentine's Day. I will be shutting down the light display on February 15<sup>th</sup>. Although, there was a desire for a 'green' St. Patrick's Day, I doubt that I can keep the lights going as wet March weather approaches.

I should also mention that we attempted to install year-round lighting on the eaves of the church, but the roof line and eavestroughs proved to be unsuitable for the installation. I had a lot of ideas for this plan, but it was not to be.

#### Christmas

As Christmas approached, I was anxious to bring our church family together again inperson. I thought we needed to do this after Covid had kept us apart for so long. The Diocese had relaxed some of the Covid restrictions and I encouraged Reverend Joan to open up St. James a little more. She agreed and I set out to write to the parish to welcome everybody back for the three services on December 19<sup>th</sup>, 24<sup>th</sup> and 26<sup>th</sup>. As I sent out the letter by e-mail, I experienced a déjà vu moment. The news was blaring as I pressed the 'Send' button for my e-mail and the story was about the fast spreading Omicron variant. I reflected back to March 13, 2020, when I sent out a similar e-mail concerning the March 15<sup>th</sup> service only to announce the church closure 15 minutes later. I had a sinking feeling yet again, and hoped beyond hope, that things would not

get bad enough to dash our Christmas plans. But it wasn't meant to be when the Diocese issued a directive to close the church on December 18<sup>th</sup>. I felt a lot of regret, but I knew it was the only safe thing to do. We made the best of it, by celebrating Christmas including a Pageant (again thanks to TAD Higginson) on-line with our friends from All Saints Greely.

#### The Furnace

As it seemed to happen in number of previous years, our furnace failed in December, just in time for Christmas. Initially, some minor repairs seemed to have repaired the problem, but it was only temporary. Replacement parts were difficult to find and would take weeks to arrive. We needed a new furnace. A pair of cheerful young men completed the job on December 24th with Christmas music playing as they worked. Reid Heating and Cooling were very sympathetic to our needs and being Christmas and a church, they offered a good price on the new furnace. We thank them for helping us out in such a timely manner.

We repeated 2020 with most our special events cancelled, including our dinners, our Yard Sale and Doors Open. This was a loss of several thousand dollars in revenue, that somehow, we managed to make up in other ways. The Foster's Market did open for the summer, but for a shortened season. It was not the best strawberry season. In the end, our share of the market sales was the best yet.

#### Thank You

I cannot write my report without a special thank you to Reverend Joan Riding. Her dedication especially under difficult covid circumstances has been remarkable. It may be true that Joan does not have to head out to our church and All Saints Greely every Sunday, but this has been more than offset by the need to keep in touch with covid isolated parishioners and those who have been ill. I know it is very demanding to offer her natural compassion to so many people, but I know this is Joan's calling. There also seems to be increasing number of parish and diocesan on-line meetings that Joan joins in with a smile, no matter how tired she may be. I can't thank Joan enough. I also thank, Vic Wootton, our Rector's Warden. He has kept certain parish ministries going despite the pandemic including Operation Christmas Child, and our monthly collection for the Pavilion Food Bank. For most of the year, he also prepared the initial draft of the bulletin for each Sunday service, and he periodically prepared the homily for our weekly worship. During the latter part of the year, Vic's eyesight deteriorated suddenly. We have worried about Vic, and we wish God's healing power upon him. The hope is that a cornea transplant will improve his eyesight in one eye considerably. We pray that a cornea will be available soon. I thank Vic for all he does for St. James. I also wish to thank Mike Thomas, who has cheerfully kept our financial records in great shape. Also, his wife, Irene, who has played all our favourite hymns on the organ both on-line and at the church. I have told Irene how much we will enjoy hearing her play again in person, hopefully sooner than later.

I also thank Deb Donoghue who has kept our meeting minutes despite trying to juggle pen and paper and a computer at the same time.

#### Remembrances

2021 also brought sad news. Many years ago, Vic Wootton was working at the church and had visitors. A couple was interested in seeing the inside of our little church. The couple was Ron and Clara Stuart. They immediately fell in love with St. James and joined us for the rest of their lives. Ron was the chair of Parish Council for several years. Clara was involved in the Ladies Guild, and both were very active in every aspect of parish life. They became a part of our church family very easily. They were also regulars at our monthly and then weekly Lunch Club. We lost Ron in 2017 and Clara with increasingly fragile health moved to Bridlewood Retirement Home shortly thereafter. Clara passed in 2021. How sad it was that Covid restrictions made it impossible to properly say our goodbyes?

Garry Cutts was my cousin, actually a double cousin. Garry and his wife Linda were my bubble family during the pandemic, and I am so thankful to them for their love and kindness. In the fall of 2020, Garry prepared boxes to protect our Christmas light plugins. They are in use at the present time. Garry and Linda joined St. James as the pandemic set in and were regulars on-line although Garry was always in a chair away from the camera. Garry passed away on July 26, 2021, following a series of events that appeared to result from an allergic reaction to his second Covid vaccination. It was truly tragic, and it was a very difficult month for Linda after Garry's admission into hospital. We pray for God's healing powers on Linda as she learns to live without her dear Garry.

#### **Our Future**

Our new Bishop was elected with a mandate to be more proactive regarding Parish Ministry. In recent years, changes at the parish level have been haphazard. Many parishes closed, amalgamated, or developed new shared arrangements called Area parishes. We have avoided this so far, but the entire diocese is now going through a new process named the 'Shape of Parish Ministry'. We cannot avoid this discussion which began in 2021 with the development of parish profiles. By the time of our February 28th Vestry Meeting, St James needs to seriously consider our future and we need everybody to participate and be on board. We are presently considered a 'Pastoral Parish' which is an independent parish that cannot finance a full-time priest. We may not be able maintain this status, so we need to prayerfully consider what is best for us in the future. By the time you read this, information will be distributed to you. Please help us by participating in the discussion.

At the same time, we need to consider a generational change. Our current lay leaders are all getting older and will not be there forever. This is an opportunity to bring new ideas forward, but this also requires some younger people to take a leap of faith and start assuming a bigger role. Is God calling you? Without beginning a generational change, St. James will have no future.

#### 2022

The Omicron variant has again closed our church since December, but hope is on the horizon. Public health restrictions began to be reduced on January 31<sup>st</sup>. My hope is

that it will become possible to safely re-open the church by Holy Week. I pray to God that this is not too optimistic. We are also taking a leap of faith by registering for Doors Open for the first weekend in June. I am looking for volunteers to welcome our guests for that event. Also, we are planning at least the outdoor component of our Annual Yard Sale on Saturday, June 25<sup>th</sup>. Our budget has been adjusted to include this, so it will happen. Please mark it on your calendar and after Doors Open, we will be welcoming donations for the sale. Let's make this a big success.

#### **Trucker Protest**

At the time of this writing, we are facing an unprecedented crisis in our city with many demonstrations and blockades by truckers and their supporters. A State of Emergency has been declared by the City of Ottawa. There have been demands for the end of all Covid restrictions, while our hospitals still remain in crisis.

We have all faced the Covid pandemic for two years. There have been many restrictions on our lives, and we have all grown very tired of them and look forward to a better future. Nevertheless, a peaceable solution is needed for the current crisis. Let us pray

O Lord our God, in your mercy and kindness, no thought of ours is left unnoticed, no desire or concern ignored. You have proven that blessings abound when we fall on our knees in prayer, and so we turn to you in our hour of need. Surrounded by cries for justice, we hear your voice telling us what is required.

"Only to do justice and to love goodness, and to walk humbly with your God" (Mi 6:8). Fill us with your mercy so that we, in turn, may be merciful to others. Strip away pride, suspicion, and racism so that we may seek peace and justice in our communities. Strengthen our hearts so that they beat only to the rhythm of your holy will. Flood our path with your light as we walk humbly toward a future filled with encounter and unity. Be with us, O Lord, in our efforts, for only by the prompting of your grace can we progress toward virtue. We ask this through Jesus Christ our Lord. Amen

#### The 141 Session of Synod for the Anglican Diocese of Ottawa

#### **Opening**

The 141<sup>st</sup> Session of Synod began with an opening prayer at 8:30 on Saturday October 30.

Prayer for deceased clergy of the past year. (Ralph Smith)
Pre-deceased by his wife Ruth who we remember very well here at St. James

An opening motion was passed that received the minutes from Synod 2020 and the financial Reports for this year.

There were 79 clergy present (last year there were only 60)

There were 155 Lay people present (last year there was only 129)

The low numbers last year due to pandemic.

#### <u>Bishop's Charge - Presented by Dave Picklyk</u>

He described how he wants us to perceive ourselves as a single Diocesan Church with two vital expressions of service to God and our world.

He asked us always to strive to refer to the church in that way.

The Bishop also spoke of four strategic priorities for the Diocese of Ottawa.

- 1. Communications
- 2. The shape of Parish Ministry and Buildings
- 3. Engagement with the world
- 4. Lifelong formation, worship and hospitality

He stated that the details will be further discussed and developed at Synod's next in person meeting. Two in person panels have started work.

- 1. The communication panel has a mandate to create a strategic communication plan.
- 2. The Shape of Parish Ministry Consultation Team is focused on the success of Parish Ministries as a whole as opposed to individual parishes.

When we meet again in person the committee will review the Diocese's structure, helping it to deliver on the third and fourth priorities, building lifelong information, worship and hospitality worldwide.

#### **Communication Logo or Brand**

- A Toronto consultant company was hired to create a brand or logo to be used to communicate with rural, city and aboriginal sections of the diocese. It was felt that communication between all elements of the diocese was a problem.
- Will be used for communication and media coverage. Get used to the design. It
  will soon be part of most communications from the diocese to us as it's creation
  is an on-going priority.

Quickly describe logo.

It will be trade marked and colour coded.

Questions concerning people who are colour blind would have a problem but we were assured that they are aware of this and have taken it into consideration..

How can parishes use this new logo. We were told that they do not expect parishes to use this brand or logo. Apparently CCC is investigating using it.

#### **Shape of Parish Development**

We (every parish completed answering a series of question concerning our parishes) There were 78 meetings with the across diocese to answer these questions. Some parishes are making use of information provided by other parishes.

We were thanked for the work done but were told that some parishes have not sent their answer to the diocese as yet. They would like them by Nov 10 and promise to release the profiles they create by Nov 24. They did indicate they may have questions concerning the answers given.

Once all are answered they will analyse the data and have something in the form of parish profiles by February.

So it is data gathering that we are involved in now (step 1) and analysis (Nov to February (step 2).

#### **Doctor John Gibault**

- talked about young people and their phones. Why can't they communicate together (different OS or platforms. This problem keeps us apart.
- Talked about how churches were formed initially.
- House churched, bishops control each church that is different. I am an anglican but my church is St. James.
- All Churches belong to God in Christ Jesus.
- Today the Diocese owns all the churches under it and the bishop. A service in BC should be the same as a service in Ottawa.
- Mont Royal service

#### **Nominations Report**

Synod approved the nominating Reort for all candidates.

Elections

We had to elect one position for Trinity College, 3 clergy for General Synod and 3 lay people for general Synod.

The one position for Trinity college was filled (Lynn Meredith)

General Synod elections were not completed as people voted twice (not me or Dave). They promised they woul;d release the results after Synod.

#### **Financial Reports**

Without going through a multitude of reports, all trust funds did well in 2020. Deloitte did the auditing and found everything accurate and clean. Synod passed a resolution to hire then again for next year. As they have been our auditors for the last several years the diocese will do a review of Delotte. A very common procedure when they have worked so many years in a row. At this time the diocese has no problems with them.

#### 125 Anniversary of the Diocese

The diocese is planning several functions to celebrate our 125 anniversary. It has been decided that the activities should be forward looking, covid free and be an instrument to launch our new brand. There will be 4 anniversary lectures:

- Indiginous lecture in December
- Jason Makinney will give a lecture in January, Environmental Lecture in February, Sam Wells (an excellent speaker), will give a lecture in March.
- All lectures will be live streamed.
- There will be a liturgy at the cathedral on New Year's Day.

Next year's Synod will be on Oct 20, 21 and 22 in 2022. Hopefully it will once again be open and face to face

The bishop indicated he will be visiting the Diocese of Jerusalem in 2022.
